## THE WOMEN UNIVERSITY MULTAN Migration Rules

Subject to the provision of Regulations, Students from HEC recognized universities & their sub- campuses duly accredited by the relevant accreditations councils (if applicable) can apply for migration to any program offered by the Women University Multan which is considered equivalent to the program offered by the other University wherein student is pursuing her Studies.

# MIGRATION

- Under special circumstances, on the recommendation of the chairperson/Director, Dean of the concerned faculty/institute and Director QEC, the Vice Chancellor may allow migration from other foreign/Pakistani universities/colleges of repute, generally under the following conditions:-
  - 1. The applicant can apply after completion of first year of study and before beginning of final year at Parent University. She should apply to WUM before the start date of a semester.
  - 2. Only those students who possess academic record comparable with admission requirements of this University (for their particular Entry Session) shall be considered for admission by migration subject to availability of seats in the concerned department.
  - 3. Courses with a minimum 60 % marks will only betransferred.
  - 4. Courses must correspond to courses offered by WUM or equivalent in depth and intensity. In most cases the an extensive test will be conducted todecipher
  - 5. The credits transferred are counted towards the degree requirement and GPA of the transferred credits shall be counted towards the calculation of CGPA.
  - 6. A migrated student is required to complete at least 50% curriculum, required for award of the degree, at WUM in order to be eligible for WUM'sdegree.
  - 7. Migration to WUM will be allowed to students admitted on the basis of WUM admission process.

- 8. Applicants who could not get admission in WUM because of not meeting the merit requirements in previous sessions are not eligible to apply formigration.
- 9. Migrated students are not eligible forHonors/Awards.
- 10. Application must be submitted at least 4 weeks prior to start of a regularsemester.
- 11. WUM authorities reserve the right to reject cases without assigning anyreason.
- 12. The PhD Scholar has to fulfill residency requirement of one year after the transfer of credit hours at WUM, even if the research work is at its final stage. Otherwise, normal duration of the program will have to follow for completion of degree.
- 13. Grading criteria/scheme of study of parent university duly signed by the higherauthority is also required

# TRANSFER

Under extraordinary circumstances, on the recommendation of the Chairperson, Dean and director QEC, the Vice Chancellor may allow transfer of a student within the Women University Multan. Provided the student fulfills the admission criteria and has gone through the full procedure of admission and passes the transfer test (if applicable) of the department in which shedesires to be transferred.

- 1. Inter-institutional transfers of students within WUM will be managed and processed on the basis of laid down procedure in vogue (As per admissionpolicy).
- 2. WUM authorities reserve the right to reject cases without assigning anyreason.

## How to Apply

- 1. Download migration form from universitywebsite.
- 2. Duly filled migration form may be forwarded to Registrar office along withfollowing:
  - a) Official transcript of semesters studied at ParentUniversity.
  - b) Photo copy of Academic transcriptsand
  - c) Detailed course outlines of courses alreadystudied.

- d) No Objection Certificate (NOC) from ParentUniversity.
- e) Character certificate from ParentUniversity.
- f) Bank draft amounting to Rs 5000/- (Rupees five thousand) in favour of WUM as migration processing fee (Rupees fivethousand).
- g) The student who will be allowed for migration to the university shall have to pay registration fee of Rs 5000/-
