5. Tender rates and amount should be filled in figures as well as in words and tender should be signed as per general directions given in the tender documents. No rebate on tendered rates will be acceptable.

Last date for receipt of Tender (s) will be **20/12/2022** till 02:00PM in L-Shape Building, The Women University, Multan (Katchery Campus) and will be opened on the same date at **02:30PM** by the respective Tenders Opening Committee at the Women University Multan (Katchery Campus) in the presence of intending contractors or their representatives.
7. The Tender(s) should be accompanied with Bid Security mentioned above in shape of CDR/Bank Draft /Cashier's cheque or bank guarantee (valid for 180 days) issued by any scheduled bank in favor of The Women University, Multan.
8. All the procurement shall be governed by the Punjab Procurement Regulatory Authority Rules 2014.
